

MU Not Anymore FAQ Spring Semester 2016

What is Not Anymore?

Not Anymore is an interactive online program designed to educate students about sexual assault, relationship violence and stalking. It also provides information about consent and teaches engaged bystander intervention techniques.

What is bystander intervention?

Bystander intervention programs empower students to identify situations in which others may need help and teach them to take action and offer assistance. Students learn to overcome their resistance to checking in and helping out. This model has been found to help reduce sexual assault on college campuses.

Why is Mizzou using Not Anymore?

Mizzou is committed to creating a safe and inclusive learning environment for all students. The online program provides introductory education and establishes expectations for our community. It also complies with the amendments to the Violence Against Women Act and the Clery Act, as well as recommendations promulgated by the U.S. Department of Education Office of Civil Rights.

Who is coordinating Not Anymore?

The Title IX Office and the Relationship & Sexual Violence Prevention (RSVP) Center, are leading this effort. We are working closely with the Registrar's Office, Leigh Durdle, MU Student Information Systems Director, and other stakeholders throughout campus.

Who will be required to complete the program?

In 2015-2016, all new, incoming undergraduate and graduate students will be required to complete Not Anymore. This includes all first-year students and transfer students. In 2016-2017, new professional students will also be required to complete the program.

Students who have experienced sex-based violence may opt out of the program by contacting Danica Wolf, RSVP Center Coordinator, at 573-882-6638.

How will Mizzou ensure all students complete Not Anymore?

This new requirement will be enforced in the same way that the requirement to have immunizations is enforced.

Beginning approximately August 1, all new students will receive a reminder in their myZou accounts if they have not completed the training. The reminder will be removed after a student completes the program. Approximately three weeks before early enrollment for Spring 2016, the reminder will convert to an Enrollment Hold. It will be applied the same day as the Immunization Hold.

How quickly will the Enrollment Hold be lifted after a student completes the training?

Typically, as with immunization holds, Mizzou's system is updated overnight. Students will be able to enroll the next day.

How will staff and faculty learn about Not Anymore?

We have been and will be reaching out to various stakeholders on campus to spread the word and solicit feedback, including Undergraduate Deans, the Advising Council, Advisors Forum, Faculty Council, the Graduate School, Provost's Staff, Chancellor's Cabinet, Staff Advisory Council, and others. Please let us know if there are other stakeholders we should be reaching.

We are also working with MU Connect to develop ways that information about Not Anymore can be shared using this tool.

How will students learn about Not Anymore?

Students will receive multiple messages in various forms of media encouraging them to complete Not Anymore. Danica Wolf, RSVP Center Coordinator, is developing a strategic communications campaign involving social media, emails, and flyers.

For example: Each student will receive several emails about the program; a flyer will be included in residence hall welcome packets for each student; flyers will also be placed on each residence hall floor; FIGs and TriGs will be provided with a discussion toolkit; the Graduate School is promoting the program; Greek Life will feature Not Anymore during recruitment and/or new member orientation; incoming students are being made aware of Not Anymore during Summer Welcome activities; reminder emails will be sent to students who have not completed the training in mid-September.

Where do students go to access Not Anymore?

Not Anymore will be accessible on the home page of the Title IX website, www.title9.missouri.edu and the RSVP Center website, <http://RSVP.missouri.edu>. Right now, the program is available at <http://title9.missouri.edu/anymore>. We are in the process of updating our websites.

Who can access Not Anymore?

Not Anymore is already available online for anyone. We hope you will check it out. You can require that anyone in your department or organization complete the training. A number of student organizations will require that their leaders complete the program. These students will not have the enrollment hold placed on their account.
